### ONLINE PORTAL: Consents, Returns and Statistics

#### > PROPERTY CONSENTS

#### Passwords

We have received a number of calls recently relating to password resets. In case people aren't sure of the process, it is outlined below:

1. Click on "Forgotten your password?"
2. Enter the email address you use to log in to the online suite and click "Proceed".
3. An email will then be sent to you called "The Methodist Church Online System: Forgotten Password".
4. Click **ONCE** on the link that says "Reset password".
5. A second email will then be sent to you with your new password.

#### Document file size

The file size limit for the document management system is current set to 5MB. We are aware that quinquennial inspections and some plans can be larger than this. However, often documents are uncompressed and can have overly large images attached. Therefore, it is recommended that any file is compressed before uploading, particular PDFs.

To use the site, simply click on "Upload files" and select the PDF you wish to compress.

#### > STATISTICS FOR MISSION

This annual statistics returns round is now underway. The changes that have been introduced since last year are designed to do two things:

- To give a clearer overall picture of what the Methodist Church actually looks like, rather than concentrating just on the number of members. We want to find out more about what else goes on in Methodist churches, and how it contributes to mission and ministry. Also about projects and fresh expressions that have a circuit-wide, district-wide or connexional appeal;
- To help churches, circuits and districts plan for mission and ministry, by giving them details about their sites and activities, and how their numbers have moved in recent years. These can be linked up to publicly available information on their local area, for instance through the ONS Neighbourhood Statistics website. The advanced version of the Methodist webmap is another tool that can help in this way.

Increasingly, applying for grants, revising the circuit plan, reporting to synod and generally planning for the future will depend on taking a good hard look across a range of factors: membership; activities; property; ministers and finance. The planned introduction of computerised reporting of churches' standard forms of accounts should help link up financial with non-financial information.

## CONNEXIONAL PROPERTY GRANTS

### Consents system

Online Property grant applications on the Consents system are now fully functional. We received 36 applications in October which will have been assessed by Streams and Grant Committees by the time you read this. During November, the Connexional Grants Committee awarded 12 property grants with a total value of £1,126,000.00. One new development with this new system is that we now have a property dashboard. This helps us keep track of all applications, from when the Connexional Grant funding request is ticked to when an application is either approved or rejected.

We are continuing to refine the questions asked on the application form and how we process applications. In the meantime, some common issues that affect applications are:

- circuit and district comments not posted
- start/finish dates not updated when timetable changes
- no district support on Grants tab
- required documents not uploaded
- authorisations missing, or
- final consent given before application complete.

We encourage all applicants to look at these carefully.

**The next deadline for grant applications over £30,000 is 2 March 2016.**

### Grants Team on the road

We were pleased to attend the District Property Secretary's gathering at Four Oaks near Birmingham recently, and it was very helpful to meet everyone and put faces to names. We were able to talk through:

- how the Grants Team can support people making applications
- the role of the District Property Secretary as a link between applicants and the Grants Team
- how to apply for a grant
- questions relating to the Consents system.

#### Membership of Methodist Church House Management Committee

We are seeking volunteers who are building services engineers to contribute to the Methodist Church House Management Committee for a period of three years.

The main purpose of the role is to be part of a team to provide advice and direction to ensure that Methodist Church House in central London is in good condition and is suitable and sufficient for its intended purpose.

The Management Committee meets four times a year for about two hours and has oversight of:

- use of premises - ensuring the property is used for Methodist Church purposes and is compliant with relevant legislation
- letting arrangements
- repair and maintenance (including rates, insurance etc.)
- preparing annual reports to the Methodist Council
- budgetary expenditure (Long Term Renewals Fund).

## LEGAL MATTERS: Gift Aid envelopes

Churches and charities have been given exemption on use of old Gift Aid envelopes.

Recently HMRC had announced details of new wording for the model Gift Aid declaration ([www.gov.uk/guidance/gift-aid-declarations-claiming-tax-back-on-donations#information](http://www.gov.uk/guidance/gift-aid-declarations-claiming-tax-back-on-donations#information)), which is due to be in force from 6 April 2016. "I am a UK taxpayer and understand that if I pay less Income Tax and/or Capital Gains Tax than the amount of Gift Aid claimed on all my donations in that tax year it is my responsibility to pay any difference".

In this new declaration, HMRC wants to remind donors that they have to inform their charities if their tax circumstances change so that the charities can adjust the gift claim they submit to HMRC. In order to ensure that both the donors and churches do not have to make any refund due to over claim, it will be useful to remind your donors to update you if they believe that the PAYE or Capital Gains Tax they have paid is less than 25% of the total donations they made to their charities.

A number of churches have thousands more Gift Aid envelopes in stock than could be used before the deadline and raised concerns about the associated waste and additional costs that would be incurred. These concerns were shared with HMRC. In response, HMRC has agreed that churches can use up their current stock (ordered up to 21 October) of pre-printed Gift Aid collection envelopes beyond 6 April 2016.

Only church Gift Aid envelopes are covered by this concession. Other declarations will need to be updated.

This is a very welcome and sensible step. HMRC's guidance will continue to recommend that all charities introduce the new wording by 6 April 2016, but will allow the current stocks of envelopes to be used up effectively.

## AUTUMN STATEMENT 2015: UPDATE

On 25 November the Chancellor delivered his *Autumn Statement* referring to some of the headline policies set out in more detail in the *Spending Review and Autumn Statement 2015* (links to the full documents at the end of this article).

Some of the points of particular interest to us include:

### Listed Places of Worship Grant Scheme

The Chancellor announced a pot of £42 million for the Listed Places of Worship Grant Scheme. This scheme covers VAT and enables listed places of worship to reclaim any VAT paid on invoices totalling over £1,000. The annual fund has now been secured for the lifetime of this Parliament.

## Listed Places of Worship Roof Repair Fund

The government has reaffirmed its commitment to a second round of the Listed Places of Worship Roof Repair Fund for churches requiring roof repairs to ensure that their buildings are watertight to prevent further deterioration in their condition. Details of the launch of this second tranche will be available soon.

## Stamp Duty Land Tax on second homes

The Chancellor announced a three percentage point surcharge on rates of Stamp Duty Land Tax on purchases of additional properties for buy-to-let and second homes.

We assume that the term 'second homes' refers to holiday homes and that, for this purpose, a house bought by a minister as a retirement property is not a 'second home' given that they do not own their manse; however, this will be raised with HM Treasury.

We await further detail about 'buy-to-let' homes as stamp duty is not usually paid by charities so this should not apply to purchases of residential property as an investment. It would certainly not apply to the purchase of a manse intended for a presbyter which is later let because of a vacancy. However, investment properties are covered by the exemption only if the profits go towards the aims of the charity, and the stamp duty would be payable if a property is purchased with the specific intent to later re-sale or if the purchasing body later relinquishes or loses charitable status.

## PROPERTY & PLANNING

### Community Infrastructure Levy: DCLG review

The Department for Communities and Local Government (DCLG) opened a consultation on 19 November 2015 as part of the review of the Community Infrastructure Levy (CIL). The Department wants to hear from a wide range of people and sectors affected by CIL on its effectiveness, together with any suggestions for changes that might improve its operation.

Given that there is an important charity exemption in place – one that the Churches Legislative Advisory Service (CLAS) and the Charity Property Association worked extremely hard to secure – the question of particular interest is likely to be question six, on the impact that exemptions and reliefs have on delivering infrastructure. The terms of reference provide additional detail on this point.

There also appears to be a focus on reviewing the relationship between CIL and planning obligations under section 106 of the Town and Country Planning Act 1990 as amended (commonly known as 's106 agreements' and for which there is no charity exemption. Extending or at least retaining the current exemption would be favourable or at least neutral; but any merger between CIL and s106 agreements could be problematic if charities were not provided with at least the same level of protection from s106 as they have now.

## Planning reform proposals and change of use

Of less immediate concern, but possibly of interest, the government's 2015 Productivity Plan set out reforms aimed at making the planning system quicker and simpler to use. The House of Commons Library has recently produced two useful publications on planning issues.

- A briefing paper setting out the Government's key planning reform proposals and those changes in the process of being made. Most of the proposed changes would apply to England only.

- A helpful note on the issues surrounding the vexed question of possible reforms to the planning use class system which, along with permitted development rights, allows change of use without the need for planning permission. Pressure for reform has been sparked off by concerns about proliferation of charity shops and hot food takeaways, coupled with the loss of local amenities such as pubs and village shops. Though not, perhaps, of direct concern to most members in managing their own property portfolios, the current system can sometimes have quite serious pastoral implications.

Sanya Strachan, Project Coordinator for the Asbury commemorations, tells us all about a connexional event inspired by our Heritage.

### Asbury 200th Anniversary Connexional Launch Event

9 April 2016, Black Country Living Museum, Tipton Road, Dudley DY1 4SQ

#### Asbury Cottage

Bishop Francis Asbury was born, brought up and apprenticed to a metal worker in England's 'Black Country': the Midlands region around Birmingham (so called because of the blackening of the buildings by industrial smoke in the nineteenth century).

This small eighteenth-century cottage was the childhood home of Bishop Francis Asbury.

Asbury founded Methodism in America and became the first Methodist Bishop in America and joint superintendent with Thomas Coke. The cottage contains information regarding the rise of Methodism in the Black Country with links to John Wesley's visits to the local area.

Although the Methodist Church does not own this property, we support Sandwell Museums and their work at this site as a way of building a better relationship with visitors to the Black Country.

To commemorate the bicentenary of the death of Francis Asbury, the Methodist Church are currently developing plans for a family celebration launch day on Saturday 9 April 2016, before a six-month programme of local commemorations in the Bristol, Birmingham, Southampton, Wolverhampton and Shrewsbury districts, which we will cross-promote.


Activities taking place will include:

- a commemoration service in the former New Connexion Providence Chapel
- a Victorian Sunday school experience (be on your best behaviour!)
- vintage bus trips to visit Francis Asbury's childhood cottage
- nail-making and chain-making in the forge (see the sparks fly!)
- an exhibition
- talks
- a 'flash mob' costumed choir, street entertainment and refreshments.



## Mission

Francis Asbury responded to a call and sowed seeds that bore wonderful fruit. Asbury was the first Joint Superintendent Methodist minister in America. He took a step of faith by going to America, and this led to Wesleyan theology being spread worldwide – which is possibly more important today than in the eighteenth century. By learning about Francis Asbury and his ministry we are reminded that “it’s not all about the Wesleys”. We’re reminded of the impact of Methodism on the industrialised Midlands of the nineteenth century. American Methodism became a global Methodism, and that was due to Asbury.

## CONSERVATION conference

Registration for the conference *Parish Church Interiors in Changing Times* is now open.

This 24 hour event will take place in Leicester **14-15 December 2015** and will explore the significance of nineteenth and twentieth century parish church interiors through presentations and group discussions, covering the interiors of churches constructed during this period, as well as internal changes made during the nineteenth and twentieth centuries to earlier buildings.

Speakers include the Right Reverend Dr John Inge, the Church of England's lead Bishop on cathedrals and church buildings and the Right Worshipful Charles George, Dean of the Court of Arches, plus papers on nationally known and locally significant architects, Victorian and twentieth-century approaches to church design, revitalising historic heating systems, responding to the challenge of major fires, and the experience of change to meet community needs. There will also be presentations on listing and statements of significance. The conference will offer DAC members and Secretaries, Chancellors, Amenity Societies, Conservation Officers, clergy, academics, architects and heritage professionals the opportunity to explore the issues raised by maintaining, using and sustaining churches with nineteenth- and twentieth-century interiors. Dr Loyd Grossman, Chairman of the Churches Conservation Trust, has very kindly agreed to be the speaker during the conference dinner.

While this particular conference focuses on the Church of England, it is hoped that there will be an opportunity to explore a knowledge-sharing event for other denominations and faith groups in due course.

## “EMBRACING ALL” at Welshpool Methodist Church

High Street Methodist Church, situated in a conservation area in the small market town of Welshpool in mid-Wales, has, throughout its 150-year history, had a reputation for welcoming both friends and strangers over its threshold.

The premises have become an integral part of community life in the town. Every day, both church groups and local organisations use them for a variety of activities – everything from line dancing to classical music concerts; Welsh and art classes to Alpha Courses; the WI to the wildlife group, the Choral Society to the church’s own Jubilate Singers.

In recent years, usage has grown to such an extent that some groups were being turned away because of lack of space and facilities. The church agreed that if it was to continue to fulfil its mission to “celebrate and share God’s love”, the building had to be developed and updated. And so in 2012, the church embarked on a £200,000 'Embracing All' project, the first two phases of which were completed in time for the church’s 150th anniversary celebrations last December.

A new meeting room, the Gallery, has been created in a little-used first floor space. It can accommodate up to 40 people, and has lift access for people with mobility problems.

Following the completion of the Gallery, work started to provide better means of access into the premises for those with disabilities.

A dedicated parking bay is now situated next to a new ramped entrance, which is well used and much appreciated by wheelchair users.

One of the most successful means of the church's outreach into the community is through its catering activities, run by a group of dedicated volunteers, who have acquired a reputation for the quality of their home-cooked food.



The Monday coffee mornings, Thursday Open Church and Heritage days, Friday seniors' afternoon tea groups, Saturday friendship lunches and monthly Sunday 'bring and share' lunches attract local non-churchgoers over the threshold, many of whom are elderly, lonely, or the more vulnerable residents of our town, who know they can find a friendly face and a listening ear (as well as good food) in a safe, non-threatening environment.

In the final phase of the project (and thanks, in part, to a £30,000 grant from the Connexional Fund for Property), the church's catering facilities are to be expanded and updated with an extended kitchen and new units and equipment – including a much needed dishwasher.

Also included in this final phase are the upgrading of the toilets, and the reconfiguring and refurbishing of the worship area to make the space multi-functional. Plans to replace the solid wood front doors with glazed units to make the church more open and welcoming have yet to be given planning approval by the necessary bodies, but a positive outcome is hoped for.

Further plans for mission and outreach next year include extending the cafe's opening, introducing a weekly lunchtime drop-in session, with a 'thought for the week' slot, and building on the Open Church and Heritage days. Our church is definitely "not just for Sundays"! As the largest and most active of all the congregations in this rural circuit (and also of the churches in the town), we are trying to safeguard this witness for future generations.

## METHODIST INSURANCE: Church property appeals grants

Methodist Insurance has a grants fund which responds to appeals for financial assistance from churches in the Methodist community for small projects where mission, outreach and the community would benefit. Grants are made out of the Company’s annual profits.

Plymouth Central Methodist Hall applied for, and was awarded, a grant towards the cost of building toilets for their youth facility. The project was initiated after working with a group of young people who started attending the church’s youth group in 2009. To access the toilets meant going up a flight of stairs, along a corridor and down another flight of stairs. This meant that the whole church had to be opened up, which made youth events harder to supervise, and caused problems of access for disabled people and those with mobility issues.

Examples of successful applications include funds for updating or improving kitchens, toilets, or entrances for specific use for community groups. Applications cannot be supported from individuals (unless it is on behalf of a church), or for general running costs such as maintenance and salaries, or where more than one application from the same applicant has been successful within a 24 month period.
