Safeguarding update Autumn Synod 2013

SAFER RECRUITMENT & DBS

The new safer recruitment guidelines were sent to all circuits in June. This is a hefty document but needs to be implemented locally for the recruitment of all paid staff and all volunteers in the churches.

We will carefully select, support and train all those with any responsibility within the Church, in line with Safer Recruitment principles, including the use of criminal records disclosures

The new DBS certificate is a part of this new safer recruitment process and should not be seen as a standalone check but as one of the recruitment checks on taking on people into roles in the churches. One of the implications of the new arrangements is the proposed enhanced role for the church safeguarding officer. The DBS certificates are only returned to the applicant and not the verifier.

The Criminal Records Bureau (CRB) is now called the Disclosure and Barring Service (DBS) - CRB checks are now called DBS checks.

The CAS on line application system for DBS checks is now live.

Please note that ministers cannot use the electronic DBS system and need to complete paper copies

Whilst those post holders that previously required a CRB in Methodism can still obtain a new DBS, there is a requirement under The Freedom of Information Act and reinforced by our guidelines, that Safer Recruitment procedures will have been followed for the appointment of both paid staff and all volunteers.
